The change in regulation (EU 2018/848) for organic products in 2022 was a massive challenge for many producers in the food and beverage industry in Europe.

The new EU organic regulation defines the requirements for natural flavours in organic products more clearly. Natural flavours now belong to the ingredients of agricultural origin once the new EU organic regulation came into effect.

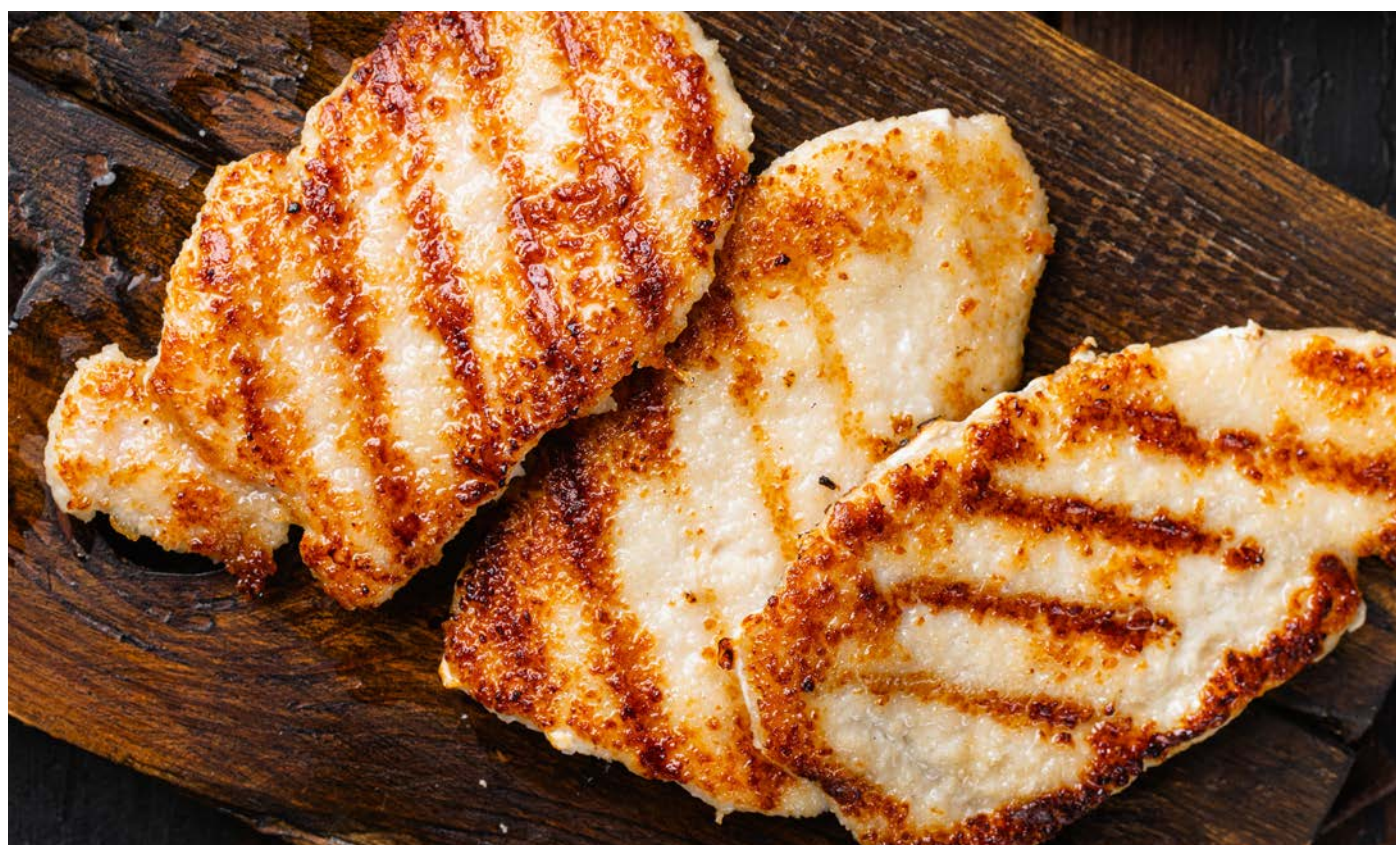
